

Euler's analysis was cursory and he abandoned the topic. Holditch takes up the issue and follows the investigation to a point where he provides actual diagrams of such curves. The practical application,

because of the corollary property of altering uniform rotation into continually varying angular velocity, had a profound impact on the design of machinery used in silk weaving and printing where this specific property is desirable. An important paper. \$250



# 12. Hilton, William (the younger) - WATERCOLOR PORTRAIT. Sir Thomas Gresham (1518-1579).

Sir Thomas Gresham was councillor, and financier in Elizabethan England as well as the founder of the Royal Exchange. Numerous portraits exist. Hilton made this skillful and appealing watercolor from the attributed Holbein portrait in the Mercers' Company Hall in London. It was once part of the Elhanan Bicknell collection (sold

by Christies in a named sale in April of 1863). The watercolor was framed (since removed and retained) and a thin, solid oak board (retained) once served as a seal to the back of the frame. The board has two labels affixed to it. One label appears to be an original gum label with 5 handwritten lines identifying the work and artist. The second is a twentieth century typed label assigning a registration number and identifying the portrait. Hilton was best known for his historically themed works and came from that British school of "effortless" watercolorists at the end of the 18th century. flame-shaped pattern). The box is lined in paper, daub blotted with a blue color. Hook and eye clasp. Overall in very good condition with some small spots of surface wear.

Commencing in the late 17th century straw marguetry was manufactured in many large cities throughout Europe. The first mention of such decorative objects and furniture is in Paris in 1652. General commerce in such goods was established by the 1750s when both Chervain and Delasson had workshops in Paris producing decorative objects with straw marguetry. The straw was first dyed then split length-wise and flattened with hammer blows. The marquetry pattern was then laid out and glued to paper that was mounted directly on to the object to be covered. Color dyes were fugitive (a result of lack of penetration into the cellulose wall structure of the straw) and rapidly faded in direct sunlight. The same process was also used as a book binding decoration. A scarce and striking broadside, presumably intended for public display, printed in Caen and dated December 1st 1806, announcing to the citizens of Calvados that a local girl from the department would be 'chosen from among women able to read and write', to be sent free of charge to Paris to attend the École d'accouchement at the Maternité, France's premier midwifery school, from January 1st 1807. The maternity school had been created only five years previously, by Chaptal. The document has been signed off by the Prefect of Calvados, Charles Caffarelli. During the 1780s, a number of provincial teaching establishments were created in France, in an attempt to curb the ignorant, and indeed

sometimes pernicious practices found amongst the poorly educated rural midwives. As part of the Revolutionary reorganization and rationalization of the medical profession an act was passed in An XI (1803) regulating the number of midwives which each individual Départements in the Country should have. It also required that they be properly trained and that they were examined before they be allowed to practice. The 'prefects' of each Department selected their candidates women between 18 and 35 - and sent them for training. The course they took was laid down precisely: as well as the theory and practice of delivery, they had to master inoculation, bleeding, and the knowledge of herbs and plants efficacious for problems during both pregnancy and birth. The students were taught by the surgeon of the hospital and by the chief midwife. At the end of their year's course they were examined by a jury of four outside professionals. The first lecturer in midwifery was Jean-Louis Baudelocque (1746-1810) while Madame Louise Lachapelle (1769-1821) was the chief instructing midwife. Other noted obstetricians and surgeons who contributed to the school and/or sat on the examining committee included Andry, Auvity, Dubois, Dupuis, Chaussier and Désormeaux. "Baudelocque received medical instruction from his father, a prominent surgeon in Amiens, at an early age. He later completed his medical education in Paris where he became the most distinguished pupil of François Louis Joseph Solayrès de Renhac (1739-1772) at the Hôpital de la Charité. By 1776 he was a member of the Collège de Chirurgie and well established in Paris as a teacher and obstetrician. After the French Revolution, with its subsequent reorganization of France's scientific institutions,

Baudelocque was appointed professor of obstetrics at the École de Santé and director of the Maternité. Baudelocque achieved a great reputation, became France's leading obstetrician, and was called upon to attend many women from Europe's top royal families. His fame and reputation also gained him some outspoken critics especially since Baudelocque was an advocate of cesarean section. It was his support of cesarean section that led him into a bitter lawsuit late in his career. Unfortunately, one of his patients died and he was forced to trial ... Baudelocque lost the suit and, in spite of his achievements and enormous professional stature, never fully recovered from the incident. Baudelocque's obstetric contributions include a forceps which he based on an earlier model of Levret as well as a pelvimeter of his own design. He also introduced a technique for measuring the various diameters of the female pelvis one of which, the external conjugate, bears his name" (Heirs 1061)



The book is divided into six parts: I - deals with pharmacy in general; II-III - the composition and preparations of medicines; IV - substances prepared by distillation; V - various chemical processes used to prepare medical substances; VI - sources of medical compounds animal, mineral, and vegetable. It became known as the "Boden" theory (G-M #5107). A superb history of the removals from the highlands and the introduction of sheep husbandry. "Loch's career was most publicly known for his part in the great and controversial changes implemented on the highland estates of the Sutherland family from 1812 onwards. The policy predated Loch but he gave it greater clarity and direction. He presided over some of the largest clearances and then spent much of his life in defence of the consequences. He believed that the highlands had been locked in feudal squalor and its people effectively enslaved under the old highland middlemen. They had been kept poor and were ravaged by recurrent famine. His mission was to release the resources of the highlands and open the region to trade and improvement. This meant the removal of the tacksmen, the introduction of commercial sheep-farming, and the relocation of the small tenantry to the coasts. His management of the Sutherland estate was excoriated as 'the Loch policy' for its inhumanity to the people who were ousted from the inland districts and replaced by sheep. The removals often required strong-arm methods which generated widespread opprobrium. Since Loch became the principal apologist for the Sutherland clearances he also attracted much of the public abuse." (DNB) \$400

New Orleans: ca1850. A proof sheet for an engraved \$5 note with a registration mark; printed in three colors and in three languages - English, French, and Spanish; recto - verso. The note measures 74 x 184 mm. The banknote engravers were:

Rawdon, Wright, Hatch & Edson - New Orleans. The main illustration on the \$5 bank note offered here appears on the firm's broadside sample sheet issued in 1843.

Very good; some toning to the paper; small marginal imperfections to some edges. An odd paper almost Japanese in composition and texture.

Rawdon, Wright, Hatch & Edson, was the most prominent bank note engraving firm in nineteenth-century America. The artistry of the firm's production set the standard for U.S. printing and engraving firms. Ralph Rawdon established an engraving and printing firm in 1816 at Albany, NY. His younger brother, Freeman Rawdon, created his own independent firm sometime after 1825. Each partnered with other engravers - Ralph with Vistus Balch of Williamstown, Massachusetts (ca. 1818-1822) and then with Asahel Clark to form Rawdon. Clark, & Co. At the same time, Freeman partnered with Neziah Wright in 1828, establishing Rawdon, Wright, & Co. of New York City. On March 1, 1832, their two firms merged to become Rawdon, Wright, Hatch, & Company. Tracy R. Edson joined the company as a business administrator at the time of this merger. Though he may have had training in engraving, he ran the operations of the firm's New Orleans office beginning in 1843. Edson returned to the main office in New York City in 1847 to administer the entire firm, at which point his name was added to the company's title as Rawdon, Wright, Hatch & Edson. In 1858 they were one of the founding members of the American Bank Note Company. The Citizens Bank of Louisiana was founded in 1833. It was the second largest bank in America. \$575

34. Commonwealth of Pennsylvania - WAR OF 1812.

**General Orders ... May 12, 1812 ....** 

Harrisburg PA: Commonwealth of Pennsylvania, 1812. First Edition. Small folio. 4 pp. Very good; old folds; some modest toning. As issued.

The State of Pennsylvania was required to draft 14,000 men into the militia to fulfill its quota for conscription under order by Congress. The document offered here has six closely printed paragraphs justifying the draft. In addition there is a detailed breakdown of the draftees for artillery, cavalry, riflemen, and infantry. There were to be 16 divisions broken down by brigade all detailed in the document. \$425
