A Treatise on Operative Surgery; Comprising a Description of the Various Processes of the Art, Including All the New Operations

Philadelphia: Carey and Hart, 1844. First Edition. Large 4to. There are 80 <u>color</u> lithograph plates.

Good; binding worn and scraped; some moderate foxing to the text; all the color plates are clean and bright; diminishing tide mark along lower border touching the text for the first 25 pages; backstrip abraded and replaced with plain linen. Later marbled paper over boards.

The text contains four sections, Elementary and Minor Operations, General Operations, Special Operations, and Plastic and Subcutaneous Operations, thereby making this the first text on plastic surgery published in the United States, as well as one of the earliest atlases of surgical procedures. Pancoast taught at Jefferson Medical College in Philadelphia. He developed a number of new operative procedures (G - M #4170 & G - M # 4855) as well as new procedures (notably the 'plow and groove' or plastic suture critical to rhinoplastic operations). The illustrations in the book are graphic, instructive, and beautifully rendered by James Queen, A. Newsam, P. C. Hollis, L. Brechemin, and S.Cichowski, The lithography is by Peter S. Duvall of Philadelphia. Norman stated in his catalog #4 (1978) that the book was hand-colored. The subtle detail features of operations are hand highlighted, but the high quality lithography of Duval shines throughout. The plates in the limited number of color copies are printed on a superior quality paper resistant to the usual foxing found in ordinary black and white issue of the book. The book in its uncolored state is widely held by the institutions and shows up with some regularity at auction; but there has been no copy of the first edition in its colored state at auction for more than three-quarters of a century. Reese, Nineteenth Century American Color Plate Books, cites only the third edition, and states: 'Pancoast's work was one of the most extensively illustrated medical works published in America before the Civil War. It was available with either uncolored or colored plates, and in the latter format it is one of the most impressive color plate books of its era.' The binder of this copy mistakenly placed two groups signatures out of order. The book, however, is complete with all 80 plates and 380 pages of text. Original wrappers.

A varied herbarium of 165 samples in their original folio collection folders. Each specimen is grouped according to the Latin genus (21 distinct groups in this collection); separate specimens are then individually identified. This herbarium has the feel of being a remnant of a larger collection. Individual samples are dated and cluster around two separate dates: those collected about 1833 and again around 1858. There are occasional notes or a printed label that identify the collector, e.g., J C Booth or J[ohn] H Balfour who were professional collectors. Many of the samples bear the initials 'H.C.' on the mount. This may correspond to Henry Carson the brother of Joseph Carson the noted medical botanist and author or possibly, though not likely, Hampton Carson, Joseph's son. The geographical range is broad, encompassing Montgomery County, PA and Cassel, Germany. Most of the collected specimens are uncommon plants. Alas, the collection originated in an auction of the remainder of the Carson family estate and there is no further information available as to its original form or purpose. 5. Carson, J. **An Inquiry into the Motion of the Blood**

A rare and very important book for the modern scientific understanding of blood flow in the human body, heart function, and in the history of cardiology. Carson (1752-1843) was a minister who received his medical degree from Edinburgh. The text is an early physiologic work on the mechanisms of venous return to the heart. In considering the causes of momentum of blood in the veins, Carson noted that, '... it will be necessary to describe the situation and fabric of the lungs with more minuteness than may appear at first view to be demanded, in an inquiry confessedly limited to the motion

of the blood.... (p.104)' He notes the obvious importance to venous return of the projectile power of the ventricles and of gravity, acting through the arteries to the ends of the veins (the vis a tergo). But additional factors are also considered in detail. ' It is plain ...,' he observed, '... that the blood could not be raised by suction alone to the heart ... unless the intervening vessels were incompressible (p.132).' However, the elastic power of the lungs, together with atmospheric weight, '... must constantly tend to dilate the heart to the utmost limits of the pericardium (p.118), so that, '... during the intervals between the exertion of the muscular energy, it becomes predominant; and, co-operating with the natural tendency of the structure, restores the chambers of the heart to the state from which they had been forced, and at which the superior strength of the contractile power begins again to be exerted (p.119).' Carson concludes, '... the motion of the blood while it flows in the veins is produced by the force of the heart and arteries urging it behind; by the abstraction of a share of the atmospheric pressure from it in front, in consequence of the resiliency of the lungs, interposing its influence in the intervals between the contractions of the heart; and by gravity, which is rendered available in this case by the projection of the arteries and the diastole of the auricles (p.151).' These observations anticipate by nearly a century the definition by Henderson and Barringer of effective venous pressure as the difference between central venous and intrapulmonary pressure (see American Journal of Physiology 1913;31:353-369). A succinct manual of plant distillates ('waters') and chemistry that are proposed as cures for various ailments. General directions for the use of the botanic remedies is given under headings for individual ailments, e.g., used as a wash for an affected limb, taken as a drink, applied with a bandage, drunk warmed up. The author is unknown, noted only with the appellation ' ... einem furnemen [sic] Medico' Remedy manuals of this vintage rarely survive. Unlocated. Absent from VD17, but the same title has one holding in VD16 dated 1600 and a different place of publication. \$2,500

Small portions of blank margins have been unevenly trimmed to facilitate folding on three plates. Generally a copy with good margins. The double page plate is close along the top horizontal margin as is plate four along the lower horizontal margin. There are two marginal tears with old repairs to the double page plate; at one point plate three has an old repair (paper flaw?) touching the engraved cross hatch shading at an extreme edge of the illustration but well within the margin. Plate five has a small old ink smudge to a blank portion of the plate. There is a 4×2 inch "crescent" of moderate damp mildew to the paper in the blank gutter at the base with an old repair to four leaves in the blank margin. Twentieth century three quarter tan leather.

Fabricius was one of William Harvey's teachers and credibly the inspiration for Harvey's conceiving his idea of the circulation of the blood (see the noted comment to Robert Boyle referred to in Grolier, Medicine, p. 104). The book offered here is the first publication of the discovery and demonstration of the valves in the veins: the investigation of which had been accomplished prior to Harvey's attendance at Padua (Fabricius claims to have noticed them in 1574 and demonstrated the fact in his lectures). Though Fabricius had re-discovered these valves (DuBois, the teacher of Vesalius, had described them at an earlier date) he failed to comprehend their true function, ascribing their purpose to one of preventing distention of the veins when blood flowed into them from an artery. Nevertheless, the publication and illustration (the powerful illustration of the circulation through the great outstretched forearm appears here for the first time in the double page plate) of this 'discovery' is a milestone in the history of medicine. The author's first book. As befitted the scion of the medical dynasty the engraved illustrations of this book are excellent. It also retains the important Addenda leaf (a cancel) that corrects an error in the body of the book. Monro offers an account of the varieties of hernias and their effect upon the bowels. Particular attention is given to the peculiar nature of the crural hernia. Here the discussion devolves into a detailed consideration of the literature and precise anatomy of the ailment. \$500

Brown was the first American physician and surgeon to limit his practice to orthopedics. He graduated from Harvard and then spent two years in Europe at the side of the continent's leading orthopedic surgeons. Kelly & Burrage cite his skill in achieving results not often seen in alleviating club-foot. This is also among the earliest medical books issued in America with photographic illustrations. "Sayre's greatest original contribution to orthopaedic surgery was in the treatment of tuberculosis of the spine (Pott's disease) with a plaster of Paris jacket. . . . It is interesting that his book, Spinal Disease and Spinal Curvature, was written and first published while he was visiting in England in 1877. In 1877 Sayre was a delegate from the American Medical Association to the British Medical Congress, held in Manchester, England. His fame in the treatment of spinal disease had preceded him, and he was asked to lecture and give demonstrations of his methods of treating tuberculosis of the spine and scoliosis in the leading surgical centers in Great Britain and Ireland. ..." (Shands, Early Orthopaedic Surgeons of America, pp. 35, 38-40; fig. 3-9 illustrates the title page). "The patient was literally suspended by an overhead traction apparatus attached to a specially constructed chin and occiput halter. Only his toes touched the ground, and this was permitted just enough to avoid serious discomfort. While under this severe traction, a snugly fitted plaster of Paris jacket was applied. Later lateral traction bands were added to the suspended body according to the nature of the deformity. and the plaster applied around them. These bands were removed before the finishing layer was applied" (Bick, Source Book of Orthopaedics, pp. 434-35). Milhalkovics wrote this to establish a systematic anatomy of the brain on the basis of it's embryological development - an ambitious goal. He cites (with a critique) the work of Reichert, published as a series of articles in 1861, for first establishing this line of inquiry. The balance of the text establishes his own observations (including microscopic sections) about neural anatomy. He worked in Budapest after studying surgery and medicine at Vienna and Leipzig. \$450

From 1872 to 1876 Hüppe studied medicine at the Univ. of Berlin afterwards serving as a military surgeon. From 1880 to 1884 he was a member of the staff in Koch's laboratory and later worked with Fresinius in Wiesbaden. He was prof. at Charles Univ. in Prague. He is best remembered for his pioneering work in bacteriology specifically on the chemical stimulation and inhibition of bacterial growth. The paper was originally presented as a speech to the Salt Lake County Medical Society. Major Girard provided expert testimony in relation to the deadly or severe wounding effect of what he considered to be small caliber weapons at long ranges (in excess of 1000 yards). The weapons were anything but "small" caliber by modern standards. But given that the study of the laws that govern the effect of shot on animal tissue were relatively new at this time Girard offers a great deal that is important. \$300

In the introduction Almeida summarizes earlier works dealing with gunshot wounds, beginning with that of Vigo and including works in Spanish, Italian and English. An important book, written for a male audience, abounding in traditional sexlore, and covering at least eight different contraceptive methods. The authorship of the work may likely have been Howard. Ostensibly translated from the French original, "Eugene Becklard" appears nowhere in French bibliographies or medical references. Howard may have felt it best to mask his authorship given the nature of the book. This 1844 printing appears 2 years after an 1842 printing in New York. Occasional marginal notes throughout by Dr. Oscar Hedenburg (Mellon Inst.), a co-worker of Nef at the time, with an unidentified presentation (but most likely from Nef, given the awkward scrawl that is indicative of his hand) to him on the front wrapper of Part III. Hedenburg's signature is on the front free endpaper as well.

Very good. A smooth linen cloth of the period with a small blindstamp along the bottom edge of the front endpaper: Bound by the University of Chicago Press. Most likely as a handful of presentation copies for Nef to distribute.

A landmark in analytical organic chemistry. Nef (1862-1915) has three chemical reaction sequences named after him. The last of the three - dealing with the fermentation of sugars - is presented in this series of offprints. The extensive and difficult multi-year research embodied in these results began with his examination of the multi-valency of carbon atoms and developed into the study of the mechanisms of dissociation of sugars and the basis of the modern concept of polymerization. Nef spent almost his entire career at the Univ. of Chicago. All of his publications appeared in German as articles in the Annalen der Chemie (his editor, writing to him in 1899, complimented Nef by stating that his published work in the journal was an "adornment" [... eine Zierde der Annalen] to the publication). It is particularly difficult to find any of his printed work since it all appeared only as articles or offprints. Complete "sets" of offprints comprising a body of work are especially difficult; more so if spread over a decade. The book also contains a separate section on dyeing fabrics. The book was used and copies do not often appear in acceptable condition (note only three holdings in Austin; supplemented by two copies that we supplied) Austin #921; Arndt #2312 (citing more holdings in central PA); Rink #1860. \$1,200

The author originally trained as a botanist and was largely self-taught. He did graduate from the Univ. of Penn. medical school. He was well known in Philadelphia and the surrounding countryside as an "accoucheur" and had a long career. The book offered here was published three years before his death with the specific intention of providing practical information for inexperienced physicians by assembling case studies that could be instructive to the attending doctor.
